



## Terms and Conditions for Exhibitors and Sponsors

### Exhibits, Advertising

Exhibitors and sponsors may use exhibits and advertising material only at their booth and in the assigned areas. The relation between exhibits/advertising material and the topics of the event has to be apparent.

### Exhibition Area

Gold sponsors will be assigned an exhibition area of 6m\*2m and exhibitors an area of 3m\*2m, each with table and electricity supply. Exhibition areas are assigned according to technical and spatial requirements. The inclusion of co-exhibitors is not permitted.

### Set-up and Dismantling

The set-up and dismantling times that will be communicated to exhibitors prior to the event are binding. Any costs incurred due to non-compliance with these times have to be borne by the causer.

### Withdrawal

Free of charge withdrawal is possible within 14 days after receipt of the order acknowledgement. After this deadline, the order amount is due in full. In case the organizer can sell the cancelled event service/exhibition area otherwise, 25% of the order amount will be charged.

### Liability Limitations for the Organizer

The organizer assumes no liability for the loss of or damage to objects belonging to the exhibitors. Exhibitors are fully responsible for their property and the areas and objects used within the scope of the event.

### Payment Terms

All prices are net and exclusive of applicable VAT. Invoices are payable within 30 days after the invoice date, without deduction, exempt from charges, and payable in Euro. Invoices will be issued after order placement and confirmation. Exhibitors and sponsors are not entitled to any event services before the invoice amount has been fully paid in due time. In case the exhibitor/sponsor fails to make the payment in due time, the organizer reserves the right to assign the exhibition/sponsorship package otherwise.

### Collateral Agreements

Any collateral agreements, amendments to or supplements of this Agreement must be in writing in order to be valid.

### Cancellation of the Event

The organizer reserves the right to cancel or postpone the event due to unpredictable circumstances. In this case, all amounts paid will be refunded in full. Additional claims against the organizer are fundamentally excluded.

### Data Privacy

For reasons of data privacy, the organizer does not disclose any contact data of the congress attendees to third parties.

### Place of Execution and Court of Jurisdiction

The place of execution and court of jurisdiction is Munich.
